Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Leyland Cypress is approx 50 ft high - circumference at base 80.5 inches. This tree is leaning outside the property boundary and pushing into the stone wall. The wall is subsequently cracking.

Monterey Cypress is approx 30 ft high - circumference at base 32 inches. This tree is unstable and excessively sways in the wind.

We are concerned that in high winds, these tree's are likely to fall down. This poses a risk to pedestrians and cars driving or parked along South Terrace. There is also a risk to the properties opposite on South Terrace as the trees are leaning that way; the branches of the Leyland Cypress overhang much of the road and branches have fallen in the past. The Leyland Cypress is also causing considerable damage to our boundary wall.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
