I have a substantial number of Ash trees within the area of my property which have died, or are significantly affected by Ash dieback with no prospects of recovery. The trees therefore require complete removal due to the state of decay. The wood in the trees has become brittle and the trees are losing branches and further at risk of falling. I have identified 39 trees which require immediate removal. Those numbered on the attached plan are identified as urgent removal. A number of trees are close to the drive which is used to access the property and accordingly they are at risk of danger to the occupants and guests. Further trees line the garden path and also therefore pose a risk to occupiers and guests using the garden due to the risk of falling branches.

The wooded area of the garden has a number of other mature trees which will be retained, including Sycamore, Hawthorne, Hazel and Holly. I am hoping that further saplings can be allowed to grow into mature trees to replace the dying Ash. .

I attach some photographs of the dying trees and I confirm that i have consulted with trees surgeons who confirm the identified trees need to removed. Further Ash Trees are currently showing signs of Ash die back but I have advised that it is possible some will survive and accordingly those will be maintained, due to their current better health and location of trees.

A further Ash large tree located immediately inside the driveway to the property shows signs of Ash die back and some large branches which overhang the drive have died and require removal. I only seek permission to prune this tree as the tree is in better health and it is hoped this tree might survive. I only seek permission to prune this tree to remove the dead and overhanging branches to make this save.

In addition to the Ash trees affected with Ash die back, I require permission for the following.

Removal of a dead apple tree.

The pruning of a Hazel Tree whose branches are growing into the telephone cable coming into the property and which risks bringing down the cable if not pruned to below this.
