Small Sycamore tree. (tree 1) to be felled. Tree is in poor condition with canker and large dead branches. It is too close to the neighbouring larger Yew and Acer trees to thrive.  Scots Pine (tree 2) to be felled. Tree is dead. It looks to be infested with a boring insect. Urgently needs felling as it is leaning towards neighbours property and sways in the wind.
