[T1] Lime: Rear of property adjacent to rear left corner of building.

Proposal: Reduce crown height by 4m and lateral spread by 1m ensuring minimum clearance from building by minimum 1.5m. Crown raise low hanging growth and epicormic growth on stem to 4m from ground level.

Reason: To control height and spread now encroaching and dominating to building. Pruning will also reduce amounts of litter drop and mossing on roof/guttering.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).
