Installation of solar PV equipment on the pitched roof of the unit occupied by Westexe to generate electricity which will not exceed 1 megawatt - the attached plans shows proposed location - there will be 1,493 panels (Suntech 410Wp-datasheet attached) plus 934 Suntech 415Wp-datasheet attached) All panels will be set at least 1m from the edge of the roof.We want to install another 237 panels on the area marked "EXTRA" and with the new permitted development rights expected on 26 December 2023 - the EXTRA area would generate 1,096.91 kWp) and we need confirmation that this is within permitted development and receive confirmation from East Devon Council that Prior Approval isn't required.
