T4 - Horse Chestnut - TPO: 212 (1972)

Mature tree in good form but needs to be reduced as one side of the tree canopy is now touching the roof of a Grade 2 Listed building (water mill).

Looking to reduce tree by 4m all around, back to appropirate growth points to achieve a good shape and far enough away from the Grade 2 Listed building.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
