Reduce and reshape to previous reduction points one Beech and two Silver Birch, retaining smaller growth at reduction points for shape. Lightly thin crown density by approximately 15%. These works are historic, and client would like to undertake the works on an annual basis to maintain the trees at a size suitable for the small garden

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
