... that it may be blown down in the increasing high winds. This would cause serious damage to our house, or to our neighbours', for which, according to our house insurance, we would be responsible.

We feel the tree is too close to the house and to the common sewer (approx 6m away) that runs along the back of the houses on the east side of White Rose Ave.

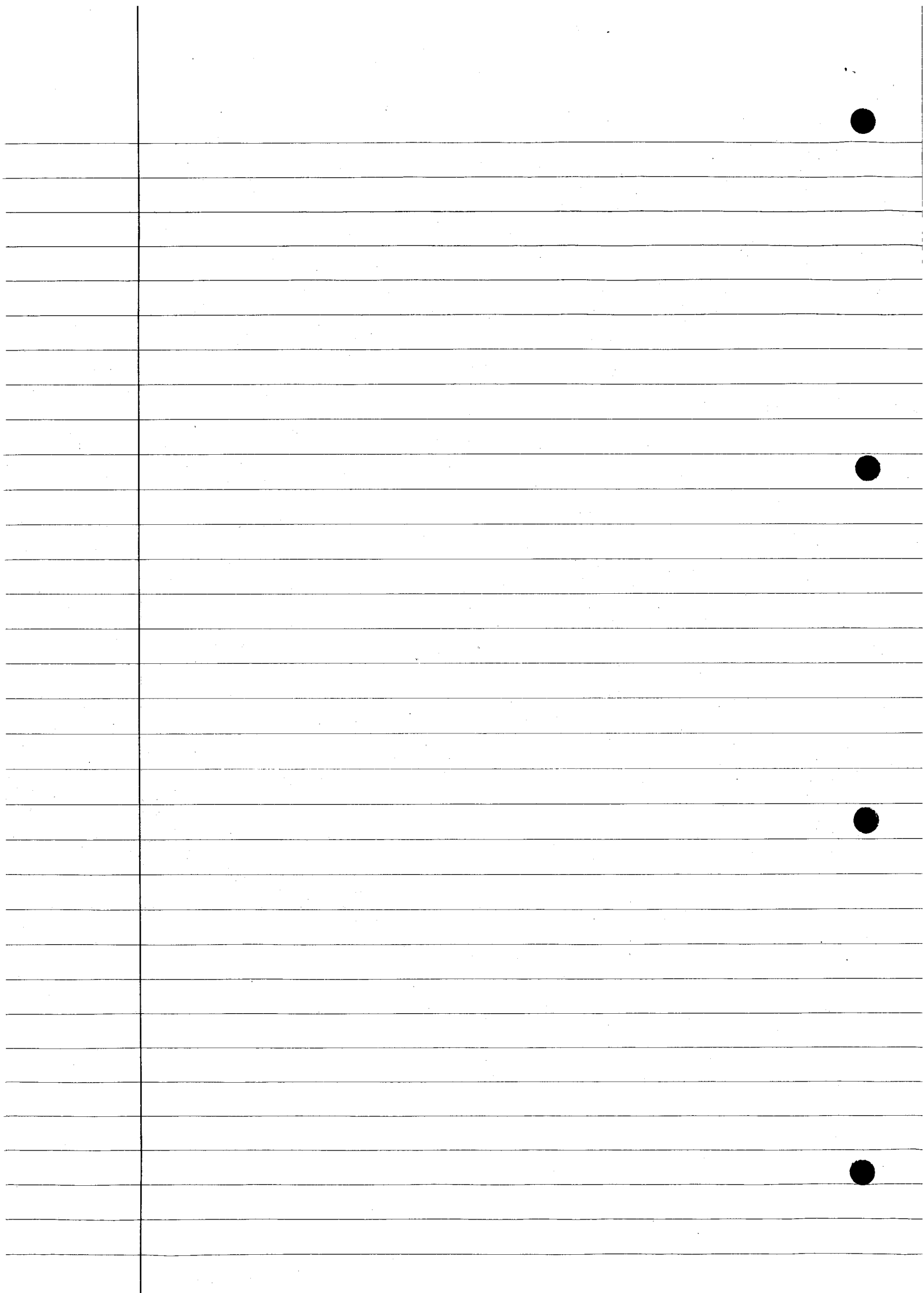
There are three large trees in our neighbour's garden on the south boundary (see nos 2, 3 and 4 on the accompanying diagram). These trees already block significant sunlight from our garden. However we are keen to create a vegetable patch and to plant fruit trees and fruit bushes (apple, pear, plum, fig, quince, raspberries, blackcurrants and blueberries), and we expect that the extra light coming into the garden by felling the silver birch will enable us to do this. The loss of the birch tree will also retain more nutrients in the soil, create more space, and leave more water in the ground for other trees and plants.

We will replace the silver birch by either one of the fruit trees or a small wildlife pond. We will decide which option when we see how big a space is created once the root ball has been removed.

We would be happy for you to come out and inspect our situation if required.
