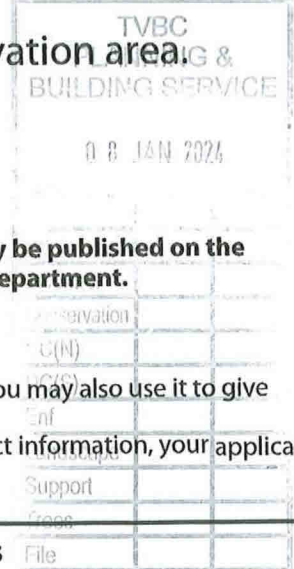

REASON FOR TREE WORKS - TREES CAUSING EXCESSIVE SHADING OVER THE HOUSE. CONCERN OVER SNAPPING BRANCHES DAMAGING PROPERTY DUE TO SIZE OF THE TREES. WHEN IN LEAF THE DROOPING BRANCHES CAUSE DAMAGE TO VEHICLES.
