### Identification of Tree(s) and Description of Works

Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Fig tree - Located on the left next to the fence. Pruning to fence height. - To improve structure and re-growth.

Bay tree - Located along the footpath on the left - Reduce in height by 50% and re shape. To improve structure and regrowth.

Pear tree - Located between two sheds - Rotting and decaying - Reduced to ground level.

Apple tree - Located in front of the shed - Reduced to ground level. To allow light to the lawn and surrounding plants.

Two conifer tree's - Located in front of shed - Dismantled to ground level. - To allow light to the garden/lawn and surrounding plants.

Bay tree - Located in read right corner - Reduced in height by 50% - To improve structure, wind sail and air circulation.

Fig tree - Located on the right hand side of the garden - Pruned to previous points. To improve structure and re-growth.

Laurel hedge - Located at the rear of the garden along boundary - Reduced in height by 2 meters to form lower more manageable hedge.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - mark and name surrounding roads
  - sketch in buildings, including adjoining properties
  - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
