They will all be registered with a GP. Most people choose to stay with their existing GP.</p> <p>Some nursing care will be provided at Bushloe House, which should help reduce the strain on community nursing services.</p>
<p>Will the proposal affect an individual's ability to improve their own health and wellbeing?</p> <p>For example, will it affect their ability to be physically active, choose healthy food, reduce drinking and smoking?</p>		<p>Yes, improved, Bushloe House will offer residents the opportunity to eat and drink regularly and healthier, with special diets where appropriate. There will be a programme of activities to enhance both physical and mental health to improve their wellbeing.</p>

Most residents will have vacated accommodation within a 5-mile radius of Bushloe House. They will all be registered with a GP. Most people choose to stay with their existing GP.</p>

<p>Services, Mental Health and Social Services?</p>		<p>Additionally, some nursing care will be provided at Bushloe House, which should help reduce the strain on community nursing services.</p> <p>Registered nurses will be on duty 24 hours a day</p> <p>Such nurses are equipped to manage medical cases of varying complexity, including the administering of medications, wound care, catheterisation and nutritional support, with assessment and monitoring as required. This will include liaising with GPs and other clinical care providers as appropriate.</p> <p>Additional services are available, from sight tests, dental check-ups to chiropody.</p>
