Due to the two buildings not finding a use or a suitable buyer, they have fallen into disrepair. As a result, the buildings have been vandalised, and the roofs have holes, allowing water to penetrate the structure. Pests and birds have gotten in and caused damage, leaving droppings and detritus. There are holes in the timber floors and stairs, meaning they are no longer safe.

The health authority has commissioned reports on the costs to restore or replace the buildings, but they have concluded it would be too expensive to restore or rebuild.
