The application is for permission to remove all of the existing garden vegetation and self-seeded trees within the red-lined boundary. The tree species includes: goat willow, ash, hawthorn, cherry and polar. The ground cover includes: snowberry, buddleia, lilac, cotoneasters, Ionicera, elder and flowering current. Two trees will be retained, these are a domestic apple identified as Tree A on the attached Block Plan and a weeping silver birch (*Betula pendula* youngii) identified as Tree B on the attached Block Plan. The boundary hawthorn hedge will be retained. Once the garden has been cleared a more formal landscape can be created in keeping with the size and setting of the property.

Identification of Tree(s) and Description of Works

Tree A will have the crown reduced to produce a better balanced crown and a clear access to the front entrance.

Tree B minor deadwood to be removed.

Tree tree works will undertaken in accordance with BS 3998:2010 recommendations for tree work and the works should be undertaken by one of the ARB approved contractors selected from the Arboricultural Association directory: admin@trees.org.uk.

The removal of the self-seeded trees will require the roots to be removed or treated with Ecoplugs Max to prevent regrowth.

The removal of the ground vegetation will be in accordance with good horticultural practise.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
