975 - Cherry - Reduce Overall size of the crown by 1.5m

977 - Hornbeam - reduce secondary growth to give 250mm clearance of the building

977c - Sycamore - reduce the laterals over the rhododendron by 2.5m to previous points

980 - Holly - carefully fell to near ground level.

 - showing the approximate distance between the application tree(s) and buildings
