Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

We plan to remove the hedge that is on our side of the boundary, install a fence along our boundary wall next to the tree with a TPO, all the holes for the concrete posts will be dug by hand with any roots to be pruned by hand if they are come across in accordance with BS3998-2012.

We are installing electric gates approximately 2 metres into our driveway. The holes for the posts for the gates are 150mm round to accommodate a 80mm post, to be installed 2ft deep into the ground. The holes to be dug by hand with any roots to be pruned by hand if they are come across in accordance with BS3998-2012.

The location of the tree is at the top left of plan 1.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
