Thank you for your email. I have amended my application to add the sycamore tree.

Looking at the photos, we want to remove about 4 to 5m from both trees, so they would both then be about 6 to 7 m. The reason for the work is they are very high and in the winter the garden and house gets very little sunlight. The Lime tree is also very close to the garage and overhangs with large branches.
