G1 constituting of 5 Holm Oaks

Remove epicormic growth on stems up-to a height of 3m. This is for aesthetics purposes.

T1 (tag 80) Holm Oak

Large split in main limb stretching 4ft long. The split travels through the other side of the limb. remove limb due to within falling distance of the main drive.

T2 (tag 17)Ash

Large elongated limb facing South East subject to limb failure due to excessive length / weight. Suggest reducing limb by 3.5 - 4m back into the drouping growth and bringing it inline with the rest of the canopy. This will also reduce the weight and exposure to the wind.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - $\circ\;$ marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
