Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

The tree lies within the ownership of Cottesmore Grange to the south of Main Street, Cottesmore. It is labelled Birch Tree on Plan 1.

Adjoining and nearby properties and their house numbers (all Main Street) are shown on the plan.

The tree is a Betula pendula, a common birch tree. We estimate its age as approx. 40 years.

We estimate the drains in the lane up to the Grange date from the Victorian period.

We wish to fell the whole tree for the following reasons:

a) the main surface water drainage pipes for Cottesmore Grange, The Stables and the whole of Manor Farm farmyard and equestrian facilities join a single pipe which runs only approx. 1.3m from the base of the tree. The drain has been blocked several times in the recent past by tree roots from the birch tree, resulting in overflowing drains and extensive flooding due to water backing up and causing damage to the equestrian stables and farmyard of Manor Farm as well as the lane leading to Cottesmore Grange. The most recent rains have resulted in significant cleanup costs at Manor Farm. There have also been costs for ourselves every time the drain is blocked by tree roots.
b) the tree is barely 0.5m from a stone wall which is also within the Conservation Area. We believe it is only a matter of time before growth of the tree results in significant damage to the wall.

The applicant was a Fellow of the Landscape Institute for over 40 years prior to retirement and has had extensive experience in managing trees and woodlands and in preparing tree management plans. He has also given expert evidence on trees at a number of public inquiries and has written reports, book chapters and papers on tree and woodland/habitat management.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

• indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:

- mark and name surrounding roads
- sketch in buildings, including adjoining properties
- add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
