No LHA have no objection to the Discharge of Condition 5 (Cycle Parking).

Conditions 4, 8 and 12 were not advised by the Local Highway Authority (LHA) who therefore have no comments to make on these details.

Advice to Local Planning Authority

Background

The Local Highway Authority (LHA) has been re-consulted on an application to discharge conditions 4 (Lighting and CCTV), 5 (Cycle Parking), 8 (Construction Method Statement and 12 (Landscaping scheme) attached to planning permission 23/0385/FUL.

The above application granted planning permission for the erection of a storage showroom and office building following the removal of existing storage containers at Regent Street, Narborough.

The LHA previously responded to this application on 2nd January 2024 objecting to the discharging of condition 5 due to its proposed location.

Condition 5

For the avoidance of doubt, condition 5 states:

'5. The development hereby permitted shall not be first occupied until such time as secure and under cover cycle parking has been provided in accordance with details that have first been submitted to and agreed in writing by the District Planning Authority. Thereafter the onsite cycle parking provision shall be kept available for such use in perpetuity.'

Highway Comments

The 'Proposed Cycle Parking' drawing (MEC, drawing number 23620_08_020_01) shows a Bike Cycle Shelter shown on site. As per 3.179 of the Leicestershire Highways Design Guide (LHDG) - all cycle parking should be secure and normally with weather protection provided at least for employee parking. The LHDG also recommends Sheffield Stands as illustrated by DG16 of the LHDG.

The applicant has demonstrated the cycle shelter will be covered, secure and consist of Sheffield Stands. The LHA have reviewed further information submitted by the Local Planning Authority (LPA) and based on the provision that staff use the rear door rather than the ground floor access, the LHA are satisfied for condition 5 to be discharged.
