Thank you for consulting the Forestry Group on application No: 23/1013/TC - Works to 3 trees within a conservation area.

The pruning works proposed within the application are; T1 - Flowering Cherry Works - Crown reduce by 20% approx 1m and thin canopy by 10%. Reason - Cyclical maintenance. T2 - Apple Works - Remove sucker growth / crown reduce by 10% approx 1m from tips. Reason - Cyclical maintenance. T3 - Sycamore Works - Crown reduce by 20% approx 1.5m Reason - Cyclical maintenance to manage size of tree due to location adjacent to properties. The proposed works are largely a repeat of previously consented works and consistent with routine maintenance which has historically been undertaken on the site. In addition the trees are unlikely to merit TPO protection and therefore I would advise that the proposed works as detailed may proceed.
