Thank you for consulting the Forestry Group on application No: 23/1021/TPO - Reduce an oak (Quercus Robur) by 25%, removing limbs between 5-8 foot, back to where it was done previously.

I visited the site today and discussed the works with the applicant. The work is a repeat of previously consented reductions to contain the height and spread of a mature oak tree within the rear of the property. Past work has been undertaken in a sympathetic manner and I have no objection to a repeat of the proposed crown reduction to the previous reduction points. This would equate to crown reduction of approximately 2 metres.

All works should be in accordance with BS3998:2010 – Tree work recommendations.
