Dear Max,

Thank you for consulting the Forestry Group on application 23/1054/TC - Beech (T1) - reduce crown back by 3-4 metres to near old cuts, by removing longest shoots and shortening remaining shoots as required; Cypress (T2) - reduce crown height by approximately 1 metre.

T1 has been previously reduced in size, presumably as a result of proximity of this beech tree to the neighbouring property. A sympathetic reduction to the previous reduction points is acceptable and should aim to maintain a balanced shape to the crown. T2 is a small cypress to the rear of the garage. The reduction in height proposed is minor and would not detract from an amenity provided.
