Work - Remove

Reason - Ganaderma applanatum decay fungi present at base with decay extending into the root plate. The tree is approx 25m tall and prominent from adjacent canopies of surrounding trees. Therefore the windloading is high. Decay will continue until failure occurs.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
