G306 Oak - Crown raise over the Northern & Western aspect to achieve 1.5M clearance from the fence & 3M above ground level over the public footpath.

T307 Oak - Remove 1.5M over Ivy from main stem.

  - showing the approximate distance between the application tree(s) and buildings
  - adding other relevant features on the site (e.g. greenhouse, paths)
