T1 Lawson Cypress remove 1 lower limb that over hangs 45 Dell road, and then trim the rest of it at the bottom so it's the same level as number 49. This is so that 45 can use their bit of the drive.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
