

GENERAL NOTES -ALL PLANT MATERIAL SHALL COMPLY WITH THE NATIONAL PLANT SPECIFICATION & BS 3936 (1992) NURSERY STOCK .

-TREE PITS. EXCAVATE PIT TO DEPTH OF ROOTBALL OR TREE ROOTS. WIDTH OF PIT TO EXTEND A MINIMUM OF C.100-150mm BEYOND THE ROOTBALL OR SPREAD OF TREE ROOTS. IF BASE OF PIT IS COMPACTED BREAK UP BASE TO ENSURE FREE DRAINAGE. IF SIDES OF PIT SMEARED OR GLAZED SCARIFY SURFACE, TOP 300-350mm OF TREE PIT BACKFILLED WITH 5 PARTS TOPSOIL AND 1 PART ORGANIC COMPOST. BOTTOM OF PIT BACKFILLED WITH GOOD QUALITY SUBSOIL FROM EXCAVATION OF PIT OR IMPORTED IF EXISTING IS OF POOR QUAUTY. NO ORGANIC COMPOST TO BE PLACED BELOW DEPTH OF ROOTS. TREES TO BE PLANTED VERTICALLY & CENTRALLY IN PITS. TREES TO HAVE THE SAME RELATIONSHIP TO THE SOIL LEVEL WHEN PLANTED TO THAT PRIOR TO LIFTING IN

CALL TREES TO BE DOUBLE STAKED: STAKES 1800mm LONG, 75mm DIAM, 600mm ABOVE GROUND, CROSS PIECES 400X1 OOX25mm, TREES TIED TO CROSS PIECES WITH TOMS FLAT BACKED PADS & 37mm WEBBING, WATERING AND AERATION PIPE (75mm PERFORATED PLASTIC PIPE WITH CAP) TO BE PLACED AROUND ROOTBALL AND EXTENDED TO SURFACE, CAPPED AND COVERED WITH MULCH.

-CONTAINER GROWN SHRUBS PLANTED IN PITS 300X300X300mm DEPTH. BACKFILL SHALL INCLUDE 3 LITRES OF PEAT FREE TREE AND SHRUB COMPOST, FERTILISING: NO FERTILISER TO BE APPLIED TO NEWLY PLANTED TREES UNLESS SPECIFIC NUTRIENT DEFICIENCIES ARE IDENTIFIED. SIERRABLEN SLOW RELEASE 15gm TABLETS TO BE INCORPORATED INTO TOP 20cm OF BACKFILL IN SHRUB PITS. SHRUBS:

5L - 3 TABLETS/SHRUB 3L - 2 TABLETS/SHRUB 2L - 1 TABLET/PLANT -ALL TREE PITS, SHRUB AREAS AND HEDGING TO BE MULCHED WITH 50mm DEPTH OF SOURCE: MELCOURT INDUSTRIES
