Our proposal is to create a fully accessible non-residential wooden cabin acting as a classroom, training centre and and eco-therapy venue at Poole Farm. This building will help us realise the vision of the Derriford Community Park Masterplan and the objectives and vision of the Lower Bircham and Seaton Local Nature Reserve Management Plan. This 'Inside/outside' design combines outdoor balcony classroom space with smaller multi-purpose rooms inside. We have included design features from young people who were asked about what they would like to see from this building. It includes 'chill out' zones to enable SEND and neuro-diverse students to have 1-2-1 and spaces and quiet areas. The Cabin will have a green roof with native wildflower plants and rainwater harvesting. It will be raised up on stilts to minimise ecological impact to the field, enable livestock to graze underneath and provide an 'immersive' farm experience for visitors. Sustainable and locally sourced timber and materials will be used throughout. The location is chosen to enable wildlife watching of the river, pond and woodlands close by to the building.
