T1 is a yew tree located at the edge of a group of approx 8 yew trees. It has a one sided crown due to competition for light from its neighbours. As such the majority of its branches extend heavily over (and are in contact with) a large wall to the east. This wall is due to be repaired and branches will need to be removed in order for this work to take place. It is proposed that T1 is removed completely to ensure that the conflict between the two does not keep repeating over the coming years, especially after the wall has been repaired.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
