T1 - Cupressus macrocarpa

Height: 14m DBH: 760mm

Crown spread: N: 0m, S: 5.5m, E: 6m & W: 6m Notes: Significant wounds at low level - see photos.

Over extension of limbs to East and included bark noted to bifurcations leaving limbs vulnerable to failure.

Proposed works: Remove to provide improved visibility to vehicular access.

Replacement planting with Tamarisk (Tamarix tetranda) in location as shown on drawing.

T2 - Cupressus macrocarpa

Height: 13m DBH: 400mm

Crown spread: N: 1m, S: 0.5m, E: 0.5m & W: 3.5m

Notes: Heavily suppressed with included bark at union and excessive stem taper leaving main stem vulnerable to failure following removal of

T1.

Proposed works: Remove to provide improved visibility to vehicular access.

Replacement planting with Tamarisk (Tamarix tetranda) in location as shown on drawing.

T3 - Cupressus macrocarpa

Height: 14m DBH: 780mm

Crown spread: N: 6m, S: 2m, E: 6m & W: 5m

Notes: Significant rifurcation at 700mm. Overextending limb to East. Proposed work: Crown reduce by up to 20% to improve form.

T4 - Cupressus macrocarpa

Height: 14m DBH: 560mm

Crown spread: N: 4m, S: 0m, E: 4m & W: 3m.

Notes: Bifurcation at 1.3m and some included bark to unions.

Dead stem at top of crown. Evidence of decay at low level (centre stem).

Currently suppressing B Grade Oak to north.

Proposed work: Crown reduce by up to 20% to improve form and favour oak to North.
