The proposal is to fell two inter-connected conifer trees which stand in the far south west corner of the garden. They are approximately 70-80 feet in height. One of the trees suffered serious damage in a storm which tore away a substantial section of the trunk. The damage left the tree lop-sided with regards to foliage and open to the weather, as well as substantially reducing its habitat potential.

An issue of growing concern is that the conifers stand within ten metres of the corner of the neighbouring house, St. Peter's Barn, towering above the property and reducing the light to the house. The prevailing westerly winds would mean that St. Peter's Barn would be at risk if the trees were to fall partially or entirely.

The conifers are also inhibiting the growth of adjacent trees and shrubs in the garden of the Old Rectory. The acidic nature of the conifer leaves has blighted the surrounding ground area. The conifers' removal would also offer more light to the surrounding species of trees.

The removal would not deplete the tree stock. The Old Rectory has the highest concentration of species within the Bramerton conservation area. Those species include mature limes, walnut, larch, oak, silver birch (6), field maple, hazel, willow, hawthorn, horse chestnut, cherry, holly, hornbeam (4), fig, magnolia, apple, plum, pear, mulberry, polonia and conifer.

Removal would be in February prior to the nesting season. The conifer would be replaced by hornbeam planting.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
