There are 4 trees that we would like to carry out work on. We would like to remove any epicormic growth and crown lift up to 4m on the beech (B1 on the sketch plan), the Sycamore S1 and the two lime trees L1 and L2. The beech tree encroaches significantly on the property to the southern aspect and we would like to draw this in by 2m on that same aspect.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)
