# Application Reference: 17/0466 - Land at Warren Drive, Thornton Cleveleys, Blackpool Woodlark Chase Residential Development – Travel Plan Monitoring Report – December 2023

# Introduction

Eddisons have been commissioned by Lovell Partnerships to formally discharge the specific Travel Plan condition relating to a residential development, known as Woodlark Chase, on land at Warren Drive in Thornton Cleveleys, Blackpool.

A planning application (App Ref No: 17/0466), which was accompanied by a Transport Assessment (TA) and Travel Plan (TP), has been granted subject to Conditions.

Condition 26 of the extant planning consent relates to the specific Travel Plan condition which is provided below:

'None of the dwellings hereby approved shall be first occupied until a Residential Travel Plan has been submitted to, and approved in writing by, the Local Planning Authority. The Travel Plan shall include measures to improve the 2 nearest bus stops on Fleetwood Road. The Plan shall then be implemented in accordance with the approved details and the implemented details shall be retained thereafter.'

# **Travel Plan**

Following the submission of an updated Travel Plan in January 2021, Blackpool Council in their role as local highway authority, discharged Condition 26 in March 2021, under Application Ref: 20/0680.

Notwithstanding the condition discharge, Lovell Partnerships are aware that they are obligated to continue to meet the monitoring requirements as set out in the approved Travel Plan for a period of 5 years.

The below action plan provides an update on the latest position of the Travel Plan for monitoring purposes.

# Year 1 Travel Survey Results

Since the initial Travel Survey, the development at Woodlark Chase is now 100% occupied and initial survey results have been obtained.

A total of 6 households out of the 86 occupied dwellings have completed the Travel Survey. This represents a 7% response rate.

Due to the low response rate, initial Travel Plan targets have been based on Journey to Work MSOA Blackpool 002 but these will be adjusted as more survey results are obtained.

The latest result of the model split results can be seen in Table 2 below:

As can be seen from Table 2, the largest travel mode in the area is that of Car Driver. However, there is currently an encouraging level of travel on foot.

Initial minimum targets for the developments model split are, therefore, proposed as follows;

- Car Driver Reduction of 5% to 58%.
- Public Transport Increase of 1% to 10%.
- Bicycle Increase of 2% to 4%.
- Walking Increase of 2% to 10%.

Ongoing actions for Year 2 will be to attempt to increase the survey response rate and to conduct an ongoing review of the modal split data to ensure the Travel Plan remains on target. The Travel Plan will be updated at the end of Year 2 if necessary.

It is considered that this approach will ensure that the Travel Plan process remains relevant and reflective and Eddisons will continue to work with Blackpool Council to achieve the goals set out within the Travel Plan.

The Travel Plan will be treated as a fluid 'live' document and any changes to Travel Plan Coordinator will be reported to Blackpool Council. The current details of the Travel Plan Coordinator are provided below:
