Single Purple Beech [Fagus sylvatica]. Last pruned March 2021 [Ref : 21/00150/VP]. Casts large shadow over rear garden when in full bloom. Inner crown is very dense, restricting light into garden and 30% of tree also overhangs neighbours property. Request to reduce crown by 20%, thin inner crown by 25%, re-shaping to balanced form. Work expected be undertaken by WOODSTOCK Tree Services Ltd, 26, Coronation Road, Downend BS16 5SL
