3 Cedar trees on left side of front entrance of convent

These trees have produced regular breakage of major limbs. Would recommend to reduce crowns by approx 2-3m to improve weight bearing and make less likely to fail during high winds

Sycamore with substantial Die Back to pollard height by approx 7m and shape accordingly

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

 - o marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
