Tree (Mimosa) with ganoderma in very poor condition overhanging house and driveway. High risk target area. Tree is twin stem and has large pruning wounds with one stem failed already and been removed leaving one stem standing. there are two large fruiting bodies (18inch approx) at the base. Also large amounts of die back in the crown with dead stems overhanging living area of building.

 - o showing the approximate distance between the application tree(s) and buildings
 - o adding other relevant features on the site (e.g. greenhouse, paths)
