Following the visit on 21 December 2023 by Matt Wilson - ISA Certified Arborist, the following works were discussed and agreed with the applicant to allow more light into the garden.

3 semi mature Sycamores just beyond your boundary

- Remove the regrowth.
- Fell the small saplings in the group.
- Cut out the dead ivy and cut any straggly ends to contain.

Application: Ref S.22/2505/TPO dated 22/12/2022 - supports this application as ongoing maintenance to trees not maintained by the owner of the land.
