T1 -T4.

Ash trees. Complete removal.

All 4 trees exhibit clear Ash die-back disease & increasingly significant, deteriorating health markers; sparse crowns, significant deadwood etc. Immediate proximity to power lines, road/parking, and most significantly neighbouring properties justifies the necessary removal of these trees as soon as possible.

Due to ill health, these trees will be dismantled using a Grapple Saw machine and deposited on the neighbouring field to be processed. Significant, adjacent trees including Beech, Sycamore & Larch will be left undamaged, to grow into the space left by the Ash trees after removal.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

  - o showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
