T.1 - Pine along rear garden boundary line, Tree has history of limb failure in high winds and snowfall - reduce 2 lower lateral branches (marked) back to parent branch union to raise crown on garden side. (Parent branch with historical hazard beam fracture)

Reduce larger lateral branch extending out of crown on garden side by 2.5-3m to appropriate pruning point to reduce end loading on main branch union and bring back into crown drip line.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
