I wish to reduce the sycamore tree (T1) in my front driveway by one third. This was last done in April 2020 and the tree surgeon advised that it would need doing again in approximately 3 years time. I have again taken advice on this matter and am being advised to apply for permission to reduce by one third.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
