Remove 2 of the least prominent stems to ground level to reduce crowding and emphasise and encourage a better form of the remaining stems.

Remove ivy and epicormic growth through.

Crown clean.

Remove 4 of the lowest branches extending over the road in the SW direction.

Reduce the lead extending NE back to the vertical growth roughly 1/3 the size to come the new lead (as marked on photo).

T2 holm oak - repollard
