1. Fruiting Cherry Tree - Crown reduction, removal of secondary trunk and general pruning to encourage fruiting and make fruit more accessible.

2. Bay Tree - Crown reduction and removal of secondary trunks and general pruning to reduce bulk of the tree to reduce overhang over vegetable garden.

3. Apple tree - pruning branches overhanging lawn.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
