'To recap on our telephone conversation regarding the above referenced approval; having commenced demolition it has become apparent that the structural raft slab has subsidised quite significantly which in turn has resulted in the front and side elevation walls (that were to remain in place) leaning over. The structural engineer has recommended that the slab is removed and existing walls are rebuilt, therefore we need to demolished these elements. We would be looking to rebuild exactly as per the current approved drawings (including those facades that were remaining in place) and have surveys of the existing facades to ensure this is done correctly.'
