149/1990-T3 - subject to TPO Species - Oak Works to be carried out: The tree is currently approximately 14m in diameter and 14m in height. It had a crown lift in 2020, but its last reduction and thin was in 2016. Crown reduction of approximately 3m in height at highest points (to previous growth points) and reduction of up to 3.5m diameter (at widest points and to previous growth points) - this will ensure our house does not have the tree canopy overhanging it, as well as ensure overhang is removed from a neighbours property. Crown thinning - in order to allow further light into our property as well as a neighbour's property - 25% maximum All work to be carried out by a local professional arborist. You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
