T1 – Weeping Willow – Remove to 4m habitat pole. (Reason - Lifting bark and cambium around entire circumference of trunk)

T2 – Small Plum tree – Remove (Reason - Poor tree its removal gives space to Pear and Apple trees)

T3 – Mixed hedgerow – Shorten to approx. 5-6ft (Requested as it is hard to cut at existing level)

T4 – Re-pollard Goat Willow. (Reason - General maintenance)

T5 – Remove Elder (Above Veg garden - Remove to allow more light)

T6 – Neighbours Horse Chestnut – Lift and to reduce overhang into garden by approx. 2m.

T7 – Sycamore – Re-pollard to previous levels. (General maintenance)

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

  - o showing the approximate distance between the application tree(s) and buildings
