At the end of a hedge on our boundary there are two leylandii trees There is only a 56 cm space between the outside of their respective trunks and they appear as though only one tree, some 10-12 metres high. Their widths are .56cm and 40cm respectively.
The application is to cut these down to ground level.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
