## Identification of Tree(s) and Description of Works

The Beech Tree is situated in the front corner of Beechcroft, 51 Ruff Lane. The tree is in a conservation area and is subject to a TPO. Over recent years it has increasingly encroached over my garden to the rear of 2, Beech Meadow. In recent winds several larger branches have been shed, narrowly missing my wife in the garden. I have consulted Paul Crabtree (arborist) and he advises that it should be possible to lop the tree back to the boundary of my property, to coincide with where it was previously lopped some years ago.

My application is to lop the tree back to the boundary of my property to coincide with where it was previously lopped

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - o marking all trees on the plan, but only numbering those to which you want to carry out work
  - showing the approximate distance between the application tree(s) and buildings
  - o adding other relevant features on the site (e.g. greenhouse, paths)
