Identification of Tree(s) and Description of Works
Please identify the tree(s) and provide a full and clear specification of the works you want to carry out

Refer to appendix 1 for location and identification of subject trees and appendix 2 for photographs and brief description of proposed work. No trees in the application are subject to a tree preservation order.

The trees & shrubs referred to in photos 1 & 2 of appendix 2 have been without maintenance for some years. The proposed work comprises reduction in height of 50% and reshaping which will benefit the health of the boundary hedge and will improve natural light into gardens either side of boundary.

Photo 3 identifies three sycamore trees and 4 sweet chestnuts. The proposed work consists of reduction in height (new growth) to the previous height reduction level which can be seen in the photograph.

Phot 4 identifies a mature cedar. The proposed work comprises trimming and reshaping the top and right hand side to protect from wind damage. Close to the rear of the cedar is a beech tree. The proposal here is to reduce the beech height by 50% to prevent entanglement with the cedar.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

Where trees are protected by a Tree Preservation Order, please number them as shown in the First Schedule to the Tree Preservation Order where this is available. You should use the same numbering on your sketch plan (see below for sketch plan requirements).

- · Tree species

e.g. Oak (T3) - Whole crown reduction to 12m above ground level, to provide sufficient clearance to property.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
  - o mark and name surrounding roads
  - o sketch in buildings, including adjoining properties
  - o add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
  - $\circ~$  marking all trees on the plan, but only numbering those to which you want to carry out work
  - $\circ\;$  showing the approximate distance between the application tree(s) and buildings
  - $\circ\;$  adding other relevant features on the site (e.g. greenhouse, paths)
