Description of works :

Tree is very close to house in back garden, branches overhang roof and gutter and concern of damage and / or damage by roots going under house so for this reason would like tree to be felled.

The tree is a cherry tree I think planted by the house builder when the house was built 26 years ago and it was planted vety close to the house. It is now a large tree towering over the house and I have concerns about its location and damage it may do to the house. It is a cherry tree not more than 26 years old and I am not sure why it is protected
