Tree examined by Mr Willis in 2021. Advised presence of fungal infection (oak bracket?). Tree core rotting. Produced hollow noise. Permission given to reduce height to 5 metres to nearest strong growth. Dead growth removed but not to 5 metres to see if more would regenerate. No growth for last two seasons save on lowest branch. Lean on tree increased. More fungus apparent further up trunk. Excessive rainfall rendered ground unstable. Height and lean of tree a danger to East Cowes Fire Station.
