T1 - Sycamore - Height reduction by 3.5m, 2.5m reduction in spread. To stop re-growth from getting too big and to reduce shading to ground below.

T2 - Oak - Height reduction by 3.5m, 2.5m reduction in spread. Reduce proximity to the house so that squirrels cannot get on to/in to the roof.
